This second supplement dated 16 November 2020 (the “**Supplement**”) to the base prospectus dated 18 June 2020 (the “**Base Prospectus**”) relating to the €4,000,000,000 Structured Medium Term Note Programme of BBVA Global Markets B.V. (the “**Issuer**”), comprises a supplement to the Base Prospectus for the purposes of Article 23 of Regulation (EU) 2017/1129 (the “**Prospectus Regulation**”). This Supplement together with the first supplement to the Base Prospectus dated 17 August 2020 and the Base Prospectus comprise a base prospectus for the purposes of the Prospectus Regulation.

Terms defined in the Base Prospectus have the same meaning when used in this Supplement. This Supplement is supplemental to, and should be read in conjunction with, the Base Prospectus (as so supplemented).

Each of the Issuer and Banco Bilbao Vizcaya Argentaria, S.A. (the “**Guarantor**”) accept responsibility for the information contained in this Supplement. To the best of the knowledge of each of the Issuer and the Guarantor the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

This Supplement has been approved by the Central Bank of Ireland (the “**Central Bank**”), as competent authority under the Prospectus Regulation. The Central Bank only approves this Supplement as meeting the the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. . Such approval should not be considered as an endorsement of the Issuer or Guarantor or the quality of the Notes that are the subject of the base prospectus and investors should make their own assessment as to the suitability of investing in the Notes

PURPOSE OF THE SUPPLEMENT

The purpose of this Supplement is to (i) incorporate by reference the Consolidated Interim Financial Statements (as defined below); (ii) incorporate by reference the Alternative Performance Measures from the 2020 Interim Report (each as defined below); (iii) incorporate by reference the Interim Financial Statements of the Issuer (as defined below); (iv) confirm that there has been no significant change in the financial performance or financial position of the Guarantor and its consolidated subsidiaries (the “**Group**”) since 30 September 2020; (v) confirm that there has been no significant change in the financial or trading position of the Issuer since 30 June 2020; (vi) incorporate certain amendments to the Form of Final Terms and; and (vii) incorporate certain amendments to the Form of Pricing Supplement.

INCORPORATION BY REFERENCE

Incorporation by reference of the 2020 Condensed Interim Consolidated Financial Statements and Interim Consolidated Management Report of the Guarantor

The parts of the Interim Report that are not incorporated herein are either not relevant for an investor or are covered elsewhere in the Base Prospectus.

If documents which are incorporated by reference or attached to this Supplement themselves incorporate any information or other documents therein, either expressly or implicitly, such information or other documents will not form part of this Supplement for the purposes of the Prospectus Regulation except where such information or other documents are specially incorporated by reference or attached to this Supplement.

Incorporation by reference of the Interim Financial Statements of the Issuer

By virtue of this Supplement, the unaudited interim financial statements of the Issuer for the six-month period ended 30 June 2020 (the “**Issuer’s Interim Financial Statements**”) are incorporated by reference in, and form part of, the Base Prospectus.

SIGNIFICANT OR MATERIAL CHANGE STATEMENT

Paragraph 8 of the General Information section on page 513 of the Base Prospectus shall be deemed to be deleted in its entirety and replaced by the following wording:

“Save as disclosed in this Base Prospectus, there has been no material adverse change in the prospects of the Group since 30 June 2020 and there has been no material adverse change in the prospects of the Issuer since 31 December 2019.

Save as disclosed in this Base Prospectus, there has been no significant change in the financial performance or the financial position of the Group since 30 September 2020 and there has been no significant change in the financial or trading position of the Issuer since 30 June 2020.”

AMENDMENT TO THE FORM OF FINAL TERMS

The first Paragraph of the Provision 1 of Part B of the Form of Final Terms for Non- Exempt Notes on page 362 of the Base Prospectus shall be deleted in its entirety and replaced with the following:

“1 Listing and Admission to Trading

[Application [has been made/is expected to be made] by the Issuer (or on its behalf) for the Notes to be listed on [the official list of] [Euronext Dublin] [Nasdaq Stockholm] [Nasdaq Helsinki] [and] [admitted to trading on [the regulated market of] [Euronext Dublin] [Nasdaq Stockholm] [Nasdaq Helsinki] [and] [Taipei Exchange (“**TPEX**”), which is not a regulated market] [with effect from [the Issue Date] [*specify*]].”

AMENDMENTS TO THE FORM OF PRICING SUPPLEMENT

The first Paragraph of the Provision 1 of Part B of the Form of Pricing Supplement for Exempt Notes on page 440 of the Base Prospectus shall be deleted in its entirety and replaced with the following:

“1 Listing and Admission to Trading

GENERAL

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Base Prospectus by this Supplement and (b) any other statement in or incorporated by reference in the Base Prospectus, the statements in (a) above will prevail.

Save as disclosed in this Supplement there has been no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus since the publication of the Base Prospectus.

In accordance with article 23.2 of the Prospectus Regulation, investors who have agreed to purchase or subscribe for any Notes before this Supplement is published have the right, exercisable before the end of the period of two working days beginning with the working day after the date on which this Supplement was published, to withdraw their acceptances. This right to withdraw shall expire by close of business on 18 November 2020.
